



AWF Trustee Role Description 2019

The Animal Welfare Foundation (AWF) is managed by a board of trustees who currently comprise qualified vets, a veterinary nurse and an animal welfare scientist. Trustees have overall legal responsibility for AWF and agree the charity's strategic direction. This is an important role which requires a commitment to work collectively in AWF's best interests.

AWF is now looking to recruit three additional trustees to replace those who are retiring on completion of their terms. We are seeking veterinary practitioners with current experience in small animal and equine practice.

AWF's mission is to improve the welfare of animals through veterinary research, education and debate. Trustees facilitate the achievement of this mission in keeping with the AWF's objectives and in compliance with legal and charitable regulations. Trustees are responsible for providing AWF with firm strategic direction, ensuring its financial stability and safeguarding its good name.

Role Description

In addition to a comprehensive induction, you will receive support and guidance throughout the role both from the AWF staff and the existing Trustee Board. Additional training can be arranged in particular areas of interest and growth.

The role will include:

1. Scrutinising Trustee meeting papers and being prepared to offer thoughts and comments at Trustee meetings.
2. Understanding and assessing the merit of funding applications made to the charity with reference to the AWF's aims and mission.
3. Contributing to AWF decision making via a Trustee email group.
4. Planning and overseeing the work of AWF as a member of one or more of the charity's sub-committees.
5. Representing AWF at external events and meetings.
6. Contributing to AWF activities such as delivering student talks and overseeing leaflet production.
7. Actively advocating and promoting the work of the AWF wherever appropriate.

In all trustee recruitment, we look for the following qualities:

- Commitment to the charity’s objectives, aims and values and willingness to devote time to carry out responsibilities.
- Strategic and long-term vision in relation to the charity’s objects and aims.
- Good independent judgement, political understanding, impartiality and the ability to think objectively in the context of the organisation and external environment.
- Understanding and acceptance of the legal duties, responsibilities and liabilities of trusteeship.
- Ability to work successfully as part of a team, communicate effectively with others and think creatively.
- Nolan’s seven principles of public life: selflessness, integrity, objectivity, accountability, openness, honesty and leadership.

Time Commitment

Trustees are expected to attend at least two Trustee meetings a year which are, for the most part, held at the AWF offices in Central London and the AWF’s annual flagship event; the Discussion Forum held in June.

In addition to this, Trustees are required to engage with one or more of the AWF Sub Committees which meet once a year in person and throughout the year via teleconference to develop AWF activities such as grant making and education.

The term time of a Trustee is 3 years, after which Trustees become eligible for re-election. A maximum of two successive terms of office may be served. The positions are unpaid, but trustees are reimbursed for travel expenses incurred.
